3) Crop damage began reporting in 2007 but research has found some earlier damage estimates and are included for those earlier years.

4) The tornado path lengths for "cross-state" occurrences are only for the Maryland portions.

5) All of the above data sources have been researched, with some having differing information, including whether original reports were revised with additional information or others having reported tornadoes that were later nullified as such. The Storm Prediction Center was previously contacted about whether their information is the standard - the reply was that the National Weather Service's surveys are what should be followed. The above table represents the best possible information that could be researched and deciphered from all official sources.

6) * The EF-2 tornado that struck the Annapolis area on 9/1/2021 caused damage along its 11.43 mile path, with touchdown in Owensville, 3 miles west of Galesville in southern Anne Arundel County, then moving northward through the western side of Annapolis. Most of the significant damage occurred in the Edgewater-to-Annapolis portion. As of 12/23/2025, property damage value has yet to be provided as both the Storm Report and Storm Prediction Center databases continue to show \$0.00 losses. If this event's damage estimate is eventually provided, it will be added to this table.

7) On July 1, 2025, severe weather affected southern Maryland, with tornadic activity in St. Mary's County. A preliminary National Weather Service Damage Survey was issued on July 2, 2025 for the EF-0 Beauvue Tornado Event. On July 11, 2025, a second NWS Damage Survey for July 1, 2025 was issued for the EF-1 Breton Bay Tornado Event. At first, it appeared to be an update of the original Beauvue tornado. An email was sent to NWS-Sterling asking if these were two tornadoes or if this new Damage Survey was simply an update to the original survey - no response has ever been received. The NWS Storm Events data now only lists the EF-1 and that survey mentions, "The tornado took a path directly along the water-land interface, becoming a waterspout on the coves along Breton Bay, then returning ashore as a tornado," yet the Storm Event database doesn't list any waterspouts. When geospatializing the two tornado track survey coordinates, it appears the beginning and ending coordinates are sufficiently different to include them as separate tornadoes and this archive was updated to reflect this. Should this information be revised, it will be updated in this archive.

The previous F-Scale was used from January 1950-December 2006, the current EF-Scale was implemented in January 2007.
